Dear Licensee:

The FCC has issued **PUBLIC NOTICE #2280** requiring all licensees of the Private Land Mobile radio service to maintain a current copy of the **FCC RULES AND REGULATIONS** governing the specific operating service. You have certified compliance with this requirement with your signature on application Form 601, which was granted 12/12/2013, by the FCC. (refer to below)

Additionally, the FCC implemented major changes to the rules, having a direct impact on the operation of your system. Specifically, **FCC Policy Statement 91-217 effective August 1, 1991, established a set of fines for unlicensed and improperly licensed use of a radio system.** Refer to reverse for partial list of violations / fines.

As a leader in licensing preparation, Federal Licensing, Inc., has compiled a complete version of Part 90 of the FCC Rules. This publication endorsed by the FCC's Field Operations Bureau, satisfies the FCC's requirement that all radio users have in their possession a **current** copy of those rules governing the radio service in which they are licensed. This publication, updated annually, will now satisfy your requirement for a full five years of your ten-year license term. **As part of this program, EACH LICENSEE WILL RECEIVE A NEW UPDATED RULEBOOK EACH YEAR FOR THE NEXT FIVE YEARS, to assure compliance.**

If you do not currently have an updated version of the **FCC RULES AND REGULATIONS** governing the **PRIVATE LAND MOBILE RADIO SERVICES** and you are currently holding a valid license, we can assist you in satisfying this requirement, simply follow the steps below:

1. Verify and correct: name, address, contact name and telephone # on the order form below.
2. Fill in the number of orders requested and amount enclosed on the appropriate line indicated.
3. Return the form below and attach it to our fee of \$119.00 per order. **(Includes 5 yrs./ Rules & Updates).**
